Assessment:

The measured contents of tyrosine, arginine and synephrine correspond to the declared values with sufficient accuracy.

Result of glutamine deviates significantly from the declared values.

The declared value for L-citrulline-DL-malate is 5000 mg per portion (14 g). The result of 3150 mg citrulline per portion is equivalent to 5561 mg L-citrulline-DL-malate per portion. Therefore the measured content corresponds to the declared value with sufficient accuracy.

The declared value for choline bitartrate is 400 mg per portion (14 g). The result of 182 mg choline per portion is equivalent to 330 mg choline bitartrate per portion. Therefore the measured content corresponds to the declared value with sufficient accuracy.

The declared value for Acetyl L-carnitine is 250 mg per portion (14 g). The result of 182 mg carnitine per portion is equivalent to 229 mg Acetyl L-carnitine per portion. Therefore the measured content corresponds to the declared value with sufficient accuracy.

Results of niacine, Vitamin B6 and ascorbic acid analyses meet the details of the nutrition labelling regarding the tests carried out (cf. Guidance document of the EU Commission with regard to the setting of tolerances for nutrient values declared on a label in food supplements from December 2012).
